RESOLUTION NO. 2015-14

A RESOLUTION OF THE BOARD OF SUPERVISORS OF KENNETT TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA, PROVIDING FOR THE SALE OF A USED AND INOPERABLE POLICE VEHICLE TO A LOCAL RESIDENT

WHEREAS, Kennett Township owns a 2008 Ford Crown Victoria, VIN 2FAHP71V28X103151 (the "Car"), that was formerly used as a police vehicle, but which is currently inoperable; and

WHEREAS, the Board of Supervisors of Kennett Township estimates that the fair market value of the Car is less than One Thousand Dollars (\$1,000.00) due to it being currently inoperable and requiring extensive transmission work; and

WHEREAS, from January 12, 2015 through January 19, 2015, the Car was listed for sale on Municibid, an on-line municipal auction site, and received no bids; and

WHEREAS, Township resident Albert Manwaring has offered to purchase the Car from the Township for Two Hundred Dollars (\$200.00); and

WHEREAS, the Board of Supervisors is authorized to sell personal property of the Township that has a fair market value estimated to be less than One Thousand Dollars (\$1,000.00) by resolution pursuant to Section 1504(b) of the Second Class Township Code, 53 P.S. Section 66504(b); and

WHEREAS, the Board of Supervisors desires to sell the Car to Albert Manwaring for the sum of Two Hundred Dollars (\$200.00), and authorize the sale by this Resolution;

NOW, THEREFORE, be it, and it is hereby **RESOLVED** by the Board of Supervisors of Kennett Township, and it is hereby **ADOPTED** and **RESOLVED** by authority of same as follows:

I. That certain Ford Crown Victoria, VIN 2FAHP71V28X103151, owned by Kennett Township and estimated to have a fair market value of less than One Thousand Dollars (\$1,000.00), is hereby authorized to be sold to Albert Manwaring, 424 Hillendale Road, Chadds Ford, PA 19317, for the sum of Two Hundred Dollars (\$200.00).

II. The appropriate officials of Kennett Township are hereby authorized to take all actions necessary to convey title to the Car to Albert Manwaring following receipt of the Two Hundred Dollar (\$200.00) purchase price.
