**ORDINANCE NO. 306**

**AN ORDINANCE OF KENNETT TOWNSHIP, CHESTER COUNTY, PENNSYLVANIA, REPEALING THE FOLLOWING ORDINANCES: ORDINANCE NO. 106 (ESTABLISHING THE KENNETT TOWNSHIP ENVIRONMENTAL ADVISORY COUNCIL), ORDINANCE NO. 118 (ESTABLISHING THE KENNETT TOWNSHIP HISTORICAL COMMISSION), ORDINANCE NO. 218 AND ORDINANCE NO. 283 (ESTABLISHING THE KENNETT TOWNSHIP TRAILS AND SIDEWALKS COMMITTEE), AND ORDINANCE NO. 226 (ESTABLISHING THE KENNETT TOWNSHIP LAND CONSERVATION ADVISORY COMMITTEE); REPEALING ALL INCONSISTENT ORDINANCES OR PARTS THEREOF; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, on May 20, 1996, the Board of Supervisors of Kennett Township (the "Board of Supervisors") enacted Ordinance No. 106, which established the Kennett Township Environmental Advisory Council; and

**WHEREAS**, on June 15, 1998, the Board of Supervisors enacted Ordinance No. 118, which established the Kennett Township Historical Commission; and

**WHEREAS**, on June 4, 2014, the Board of Supervisors enacted Ordinance No. 218, which established the Kennett Township Trails and Sidewalks Committee; and

**WHEREAS**, on March 20, 2019, the Board of Supervisors enacted Ordinance No. 283, which amended Ordinance No. 218 regarding the Kennett Township Trails and Sidewalks Committee; and

**WHEREAS**, on December 17, 2014, the Board of Supervisors enacted Ordinance No. 226, which established the Kennett Township Land Conservation Advisory Committee; and

**WHEREAS**, the Board of Supervisors has carefully reviewed each of the four (4) advisory bodies created by the above-referenced ordinances and has concluded that the Land Conservation Advisory Committee should be abolished and replaced by a contract for land conservation services with the Brandywine Red Clay Alliance, and that the Environmental Advisory Committee, the Historical Commission, and the Trails and Sidewalks

Committee should be re-established by resolution of the Board of Supervisors;

**NOW THEREFORE**, be it **ENACTED** and **ORDAINED** by the Board of Supervisors of Kennett Township as follows:

1. Kennett Township Ordinance Nos. 106, 118, 218, 283, and 226 are hereby repealed in their entirety.
2. All ordinances or parts thereof inconsistent with this Ordinance are hereby repealed to the extent of the inconsistency.
3. The provisions of this Ordinance are declared to be severable. If any provision of this Ordinance is declared by a court of competent jurisdiction to be invalid or unconstitutional, such determination shall have no effect on the remaining provisions of this Ordinance or on the provisions of the Code of Ordinances of Kennett Township.
4. This Ordinance shall become effective five (5) days following its legal enactment.
